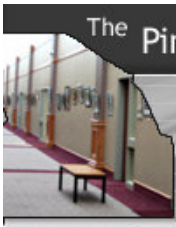

*For an annual fee of \$20.00 (in addition to annual membership fees), members will receive space for verbiage, contact information, and nine (9) images with the artwork info. The information required to complete this web page: member's name, contact information, telephone, e-mail address (if applicable), other web site links if desired, 2 or 3 paragraph bio, medium, artwork(s) titles, dimensions (i.e., 16x20 framed w/o glass, acrylic), and the price. A \$5 additional fee will be charged for each additional change outside of the nine (9) images. For example, if you sell an artwork and wish to add another image in the sold image's place, a \$5 fee will apply. Please notify **Annette Hutchins** or **Shirley Dawson** at 870.692.6938, once an artwork is sold so the image can be marked "SOLD."*

The PBAL will charge a 20% commission for all sold paintings on the PBAL Web Site.
